### **FUND MANAGER'S COMMENTS**

Global market started a new year in 2025 with plentiful events including CES event which managed to boost the Al sentiment albeit then hit by DeepSeek news in the middle of January, Trump inauguration day followed by his rapid changes of tariff implementation plan as well as "big talks" about taking over Canada and Greendland, and higher 10 Y and 30 Y interest rate reflecting a bear steepening yield curve due to expectation of inflation which might force US Federal Reserve to eliminate any rate cut decision for the year With more inflation data updates and Federal Reserve speakers' commentary, interest rate gradually reversed back to more sensible expectation Albeit all the headline noises and macro updates, 4 QCY 24 earnings showed that 60 of S&P 500 25 of STOXX 600 50 of TOPIX companies which reported have delivered both better sales and earnings beats We could expect the market performance to continue improving from here assuming that current solid growth trajectory continue throughout through 2025 while acknowledging the elevated volatilities from market headlines MYR Class A delivered a return of 2 20 underperforming the benchmark by 28 bps as the performance attribution to the allocation was fully offset by the selection.

By region, EU stood out as the best performing market showing some recovery from better than fear earnings result and the low base rate in 2024 while US market has been dragged by the IT pullback due to some AI capex fear By sector, Healthcare delivered better than fear earnings result which stood out as one of the best performing sectors.

## FUND MANAGER'S COMMENTS (CONT')

The top contributors were Boston Scientific and Thermo Fisher Both companies attended JP Morgan Healthcare Conference in the middle of the month and provided some assuring outlook updates which supported investors' confidence Following the conference at the end of the month, Thermo Fisher delivered earnings beats and raise The management highlighted that company would be targeting solid high single digit range earnings growth with the main focus on improving its profitability albeit that growth outlook remains uncertain On the other hand, the top detractors were Tetra Tech and due to not investing in Meta Platforms and Amazon While Tetra Tech had delivered strong quarterly earnings with 10 sales and 6 EPS beat, we observed meaningful multiples de rating which reflect investors' concern around the impact from halting USAID funds and other potential US federal government spending. The selling action was further intensified by its respective volume liquidity.

#### Impact Focus of the Month

The team added a new position in Broadcom over the month and whilst this is certainly not one of the most impactful holdings the total impact assessment we have made from both its operations and products reaches the threshold set for the Fund Broadcom has technology leadership in networking chips and custom ASICs, and both of these capabilities are being deployed in the AI infrastructure of public cloud companies at an accelerating rate We believe that the market underappreciates from an impact perspective how Broadcom's networking and computing chips support energy efficiency Energy efficient chips are a growing requirement for public cloud datacentres as AI consumes a huge amount of electricity Their AI accelerators will further continue to contribute to society as AI innovation leads to breakthroughs in drug discovery and climate models.
