PERFORMANCE RECORD

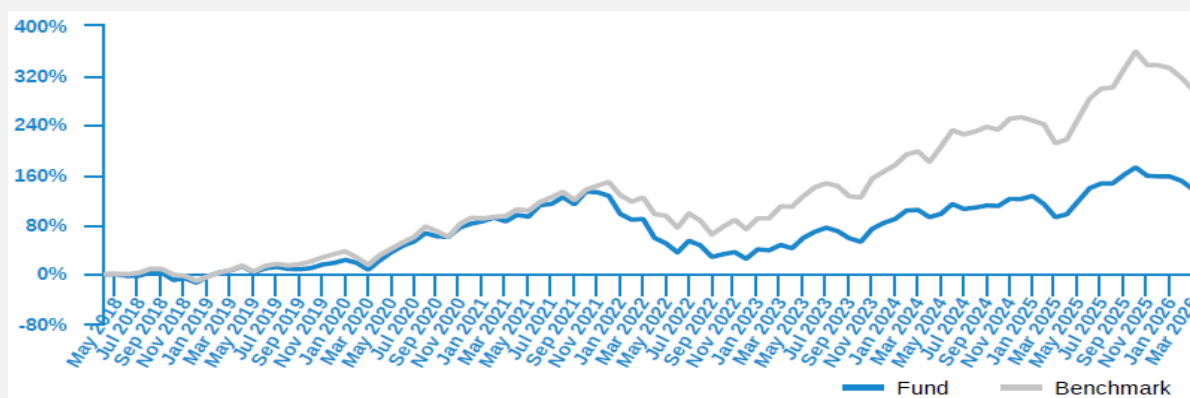

FUND MANAGER'S COMMENTS

The Fund fell 5.03% during the month, underperforming the benchmark by 0.44%.

Global equity markets retreated in 1Q26 amid heightened volatility, driven by geopolitical tensions particularly the Middle East conflict which disrupted energy markets and intensified global inflation concerns. Sector performance was mixed: six of 11 major sectors posted gains, led by energy, utilities and materials, while IT, communication services and consumer discretionary lagged. The IT sector experienced pronounced internal rotation. According to the MSCI ACWI, IT and communication services declined 6.7% and 7.8% respectively, with sharp losses in software and IT services as valuation resets, AI monetisation uncertainties and cautious spending pushed both into bear market territory. In contrast, semiconductor-related segments, electronic equipment and communications equipment outperformed, supported by robust hyperscale AI capital expenditure, supply tightness and pricing power.

We remain positive on technology sector fundamentals heading into April and see recent volatility as temporary. We believe economic growth and inflation signals point to a supportive environment for growth equities. While tariff uncertainty isn't completely behind us, we think the more pertinent macroeconomic debates will shift towards the pace of monetary easing, the impact of lower US taxes on consumer spending and business investment, deregulation and AI-driven productivity gains.
