

FUND MANAGER'S COMMENTS

The Fund increased 0.15% during the month, underperformed the benchmark by 0.29%.

Global equities delivered solid gains overall during August 2025. Nevertheless, US equities slightly lagged global stocks, partly due to the underperformance of the information technology (IT) sector. There was a mixture of gains and losses among the IT sector's six industries, led by above-average returns in technology hardware, storage and peripherals; communications equipment; and electronic equipment, instruments and components. Investor concerns were further stoked by regulatory uncertainties, cautionary remarks from AI leadership, and perceived signs of overvaluation. Many businesses, worried about rising costs and policy unpredictability, have decided to pull back on their long-term IT investments for the time being.

We continue to position the portfolio towards durable growers tied to AI and other Digital Transformation themes, and those less sensitive to trade policy. We also believe that in the latter half of 2025, the market's attention may shift to supportive monetary policy, deregulation, and AI-driven productivity gains, all of which could help support the US economic backdrop. AI should remain an important driver for IT sector growth, and we continue to see stronger earnings growth for the sector relative to the broader market.
