

FUND MANAGER'S COMMENTS

In January 2026, the Fund's performance increased by 0.58%, underperforming the benchmark by 1.38%.

The FBM KLCI rallied a further 3.6% in January following a strong December 2025 on the back of the Ringgit strength. We believe sentiment was largely lifted by improved sentiment on the Ringgit which gained ~3% against the Dollar, exacerbated by the severe underweight position by global funds on Malaysia, coupled with the encouraging 4Q25 GDP reading.

The KLCI is now trading at a forward PE of c.15x, which is at the 10-year historical mean straddling Covid-19, but still over -1.5SD below the mean of 16x for the 5-year period preceding 2020. Consensus now projects earnings growth for FBM30 of c.1% for 2025 and 9% for 2026. Sustained strength in domestic investments (both DDI and FDI), fiscal consolidation gathering pace (in particular, subsidy rationalisation initiatives) and the strengthening of the Ringgit are factors we see supportive of the further narrowing of risk premiums, and consequently higher valuation multiples.

The MGS yield curve saw a modest curve twist in January with front-end yields edging higher, as the 3-7y segment rose by 3 to 6 bps. In contrast, the belly out to 15y saw modest declines of 1 to 3bps suggesting demand for intermediate tenors and limited change in medium term inflation and growth expectations. Slight steepening was seen at the long end likely reflecting supply term premium dynamics with meaningful duration supply during the month. (i.e. 15y MGS new issue and 30y MGII new issue). The 3-, 5-, 7-, 10-, 15-, 20- and 30-year MGS closed at 3.11% (+2bps), 3.33% (+3.), 3.45% (+6bps), 3.52% (-1bp), 3.77% (-3bps), 3.93% (+7bps), and 4.02% (+4bp) respectively in January.

BNM is expected to keep the overnight policy rate (OPR) unchanged at 2.75% through most of 2026 amid stable domestic growth and inflation, while global central banks such move toward easing, narrowing yield differentials and enhancing the carry appeal of MYR bonds.
